# JIM THOME

was a career .276 hitter compiling 2,328 hits and 1,747 walks while playing in 2,543 games at third base, first base and designated hitter. He played in 22 seasons with six different teams including the White Sox, Indians (twice), Phillies (twice), Dodgers, Twins and Orioles. Thome is currently in 7th place on the Major League Baseball all-time home runs list with 612 and 24th on the MLB all-time RBI list with 1,699. He was a five-time MLB All-Star, Silver Slugger Award winner, National League Home Run Champion as well as receiving numerous other on and off the field awards throughout his celebrated career. While with the White Sox for 2006-2009, Jim hit his 500th home run on September, 16, 2006 in walk-off fashion to give the Sox a 9-7 victory against the Angels.

## JIM ADDUCI

Former left-handed hitting outfielder and first baseman that played for the St. Louis Cardinals, Milwaukee Brewers and Philadelphia Phillies. Professional playing career lasted from 1980-1990. Jim Adduci serves as the Director of Elite Baseball for the Bulls/Sox Academy.

## DAN PASQUA

Pasqua was a power-hitting outfielder and first baseman known for hitting tape-measure home runs for the White Sox from 1988 to 1994. Over his 10 year major-league career he slugged 117 home runs and 390 RBI. Dan currently runs the White Sox Academies in Glen Ellyn and La Grange, developing ball players through private and semiprivate training lessons.

## MICHAEL HUFF

Michael is a former White Sox outfielder and was a member of the 1993 American West Division Champions. During his professional playing career, not only did he play with our beloved White Sox but roamed the field with the Dodgers, Indians, and Blue Jays. Michael Huff serves as the VP of Baseball/Fastpitch Department for the Bulls/Sox Academy.
